3/28	S4	Commercial Burglary	Between 4:45 PM on 3/25 and 3:00 PM on 3/26, unknown suspect(s) made entry into the fenced off area of a residence under construction in the 22000 block of Mt. Eden Road and took construction tools and supplies including an unknown amount of copper piping for a total loss of about \$4,100.
