9/5	S2	Criminal Threats, Public Intoxication ARREST	At 1:55 AM, deputies were flagged down by a victim in the area of Prospect Road and Saraglen Drive. An investigation revealed the suspect left criminal threats on the victim's voicemail. Upon contact with the suspect, further investigation revealed the suspect was unable to care for himself due to being under the influence of alcohol. The suspect was arrested and booked into Main Jail.
9/5	S1	Non-Injury Hit and Run Collision, DUI ARREST	At 2:26 AM, deputies responded to a non-injury hit and run vehicle collision that occurred in the 12000 block of McCarthysville Place and stopped the suspect vehicle in the area of Brandywine Drive and Brandywine Court. An investigation resulted in the arrest of the suspect driver for driving under the influence of alcohol. The suspect was booked into Main Jail.
9/5	S2	Possession of Ammunition by Prohibited Person, Unlicensed Driver ARREST	At 3:13 AM, deputies stopped a motorist at Saratoga Sunnyvale Road and Sea Gull Way. An investigation revealed the suspect driver had a felony conviction and was in possession of ammunition while driving without a valid driver's license and the suspect passenger had an outstanding warrant. Both were arrested and booked into Main Jail.
9/5	S3	Non-Injury Collision, DUI ARREST	At 8:13 PM, deputies responded to a non-injury vehicle collision at Saratoga Avenue and Kosich Drive. An investigation resulted in the arrest of the suspect driver for driving under the influence of alcohol. The suspect was booked into Main Jail.
9/7	S5	Armed Robbery	At 9:21 PM, unknown suspect(s) approached the victim in the 14000 block of Big Basin Way, pointed a gun at the victim and demanded the victim's wallet. The victim complied for a total loss of about \$40. The suspect(s) fled the scene and are at large.
9/7	S5	Reckless Evading of a Peace Officer ARREST	At 10:30 PM, deputies attempted to stop a motorist at Big Basin Way and 3 rd Street, but the vehicle fled at high rates of speed, committing numerous vehicle code violations, before colliding with another vehicle and then into a hillside. The suspect was arrested and booked into Main Jail.

9/8	S4	Stolen Vehicle	Between 5:00 PM and 9:00 PM, unknown suspect(s) stole a vehicle parked in the 20000 block of Reid Lane. The vehicle had an unknown value.
