### SITE VISIT AGENDA:

**Application PDR16-0001/ARB12-0057; 13845 Pike Road (503-30-003); Lands of Liu.**

The applicant is requesting Design Review approval to remodel an existing 1,361 square foot two-story split level single-family home located at 13845 Pike Road. Proposed improvements would include a 648 square foot lower story addition and a 508 square foot upper story addition for a total square footage of 2,517 square feet.
