5/14	S4	Injury Collision	Occurred at 7:15 PM at Tollgate Road and Saratoga Heights Drive.
5/15	S2	Petty Theft	At 9:10 PM, unknown suspects entered an unlocked vehicle parked near Safeway in the Argonaut Shopping Center on Saratoga Sunnyvale Road and took cash, documents and keys for a total loss of about \$250.
5/15	S3	Carrying a Concealed Firearm ARREST	At 11:37 PM, deputies stopped a bicyclist near Prospect Road and Lawrence Expressway for traffic violations. An investigation revealed the suspect bicyclist was carrying an unloaded firearm in his backpack. The suspect was arrested and booked into Main Jail.

5/16	S8	Reckless Evading	At 9:18 AM, deputies attempted to stop a motorist at Saratoga Avenue and Highway 85 for a traffic violation, but the suspect driver did not yield and recklessly evaded. The pursuit was terminated in the interest of public safety and the suspect driver is unknown and at large.
5/16	S7	Non-Injury Collision	Occurred at 2:27 PM at Fruitvale Avenue and Allendale Avenue.
5/17	S8	DUI ARREST	At 11:12 PM, deputies stopped a motorist at Saratoga Avenue and McFarland Avenue for a traffic violation. An investigation resulted in the arrest of the suspect driver for driving under the influence of alcohol. The suspect was booked into Main Jail.
